Product Information

IMPURITIES: This product contains heavy metal impurities. Its use may lead to an accumulation of Cadmium and Lead in the soil. Depending on the soil characteristics, irrigation water quality, plant species and variety, crop uptake of Cadmium may exceed the maximum limits allowed in food standards. In pasture, the offal from grazing animals may also exceed these limits.

DIRECTIONS FOR USE: A coarse, granular or small prill or fine powder fertiliser grade of potassium sulphate, for use where soil or irrigation water is high in salt or chloride. Use to replace potassium chloride (MOP) where chloride sensitive crops are being grown, e.g. berries, vines or where quality or cadmium uptake may be affected by excess chloride, e.g. Potatoes and leafy vegetables. This product may be used as a foliar fertiliser.
