**DIRECTIONS FOR USE:** A granulated barium selenite (75%) + carrier fertiliser for dry application to the soil. Do not apply any more than 0.01 Se/ha. Excessive use of selenium (Se) can be toxic to livestock. This product should not be used if selenium deficiency does not exist in stock grazing on the area where it is to be applied. Do not allow stock access to spilt or unused fertilizer. This product must not be applied at a rate greater than that stated on the label or advice note.
